

• Networking/Social Activities: No networking activities happened in 2020. Cohen will bring the ideas slated for 2020 to the table for 2021.		
• Student Chapter and Scholarship: Glasser summarized the activity in 2020; the scholarships were eliminated; a survey was conducted to understand the membership staffing needs and associated training; purchased laptops and cellular routers for students to help with COVID. In 2021, the current direction may include offering mentorships for ages 18+ for those exiting the Boys & Girls program and networking opportunities for the Boys & Girls program. The contracting community tends to feel isolated from the ITS Georgia community, so there is a need to be more inclusive, and possibly recruit a person from the contracting community on the board. Glasser will be more engaged with the TIME organization and ITS Georgia and seeks to support the training for all types of ITS professionals; similarly, GDOT's objective is also to provide increased and enhanced training opportunities in 2021. The member agencies of ITS Georgia are welcome to provide resources for training improvements and enhancements, which could be a key element of attracting new organizations to ITS Georgia.
